1. Call to Order

3. Closed Session

4. Business Arising from Closed Session

Council reconvened in Open Session at 8:43 p.m. Mayor Hankivsky advised that during the Special In-Camera Session, Council approved the Special in-camera minutes from October 29, 2024 and the Special incamera minutes of November 5, 2024. She advised that Council received information regarding recruitment of senior leadership position or positions within the municipality.

Mayor Hankivsky reported that Council also considered matters related to the recruitment of the Interim CAO position, and provided direction to staff. It is anticipated that an appointment by-law to appoint the Interim CAO will come forward for Council consideration at an upcoming meeting. Council also received information regarding the recruitment and selection process for the permanent CAO position and provided direction to Council Members, staff and to the external recruiter. Mayor Hankivsky reported the following outcomes:

- Council has authorized an external recruiter, Feldman Daxon, to commence with the recruitment for the permanent CAO position.
- A selection committee comprising of three Council Members will be tasked with reviewing applications, selecting candidates and conducting interviews to determine the final candidate or candidates to be presented to Council for final approval.
- Once the final candidate has been selected, and an employment agreement has been negotiated, an appointment by-law to appoint the permanent CAO will come forward for final approval at a meeting of Council.
- Timelines for recruitment anticipated to be complete by Spring 2025.

Mayor Hankivsky advised that Council also received confidential information from the Province for future regulatory opportunities in the Municipality. As the information is circulated by the Province in accordance with their timeline, more information will become available through municipal communication channels.
