

# THE CORPORATION OF THE MUNICIPALITY OF PORT HOPE

## BY-LAW NO. 73/2022

*Being a By-law to appoint a Temporary Chief Building Official, Deputy Chief Building Official and Building Official/Municipal Law Enforcement Officer for the Municipality of Port Hope*

WHEREAS Council at their regular Council meeting held on December 6, 2022 considered Staff Report PS-07-2022 regarding Protective Services Appointments;

AND WHEREAS it has been identified that a temporary contract Chief Building Official, Deputy Chief Building Official and Building Official / Municipal Law Enforcement Officer have been identified to provide service to the Municipality of Port Hope on an interim basis to ensure continuity of the Building Services Division until permanent successors are appointed to these positions;

AND WHEREAS Section 23.1 of the Municipal Act, allows council to delegate the Chief Building Official and other Building Officials as required;

AND WHEREAS Council deems it desirable to appoint a temporary Chief Building Official, Deputy Chief Building Official and Building Official/Municipal Law Enforcement Officer on the date of passage of this By-law;

AND WHEREAS the Building Code Act, 1992, S.O. 1992, as amended Chapter 23, Section 3(2) provides for the appointment of a Chief Building Official and such inspectors as are necessary for the enforcement of the Building Code Act;

AND WHEREAS the Building Code Act, 1992, S.O. 1992, as amended provides for the appointment of a Municipal Law Enforcement Officer who has been assigned the responsibility of administering and enforcing by-laws passed pertaining to Property Standards, in accordance with Sections 15.1 to 15.8 inclusive;

NOW THEREFORE the Council of the Corporation of the Municipality of Port Hope enacts as follows:

1. That Gerald Moore is hereby appointed as a temporary Chief Building Official for the Corporation of the Municipality of Port Hope.
2. That Devon Staley is hereby appointed as a temporary Deputy Chief Building Official for the Corporation of the Municipality of Port Hope and shall have the same powers and authority for enforcement of the Building Code Act, the regulations and By-laws thereunder as the Chief Building Official.
3. That Jacquie Hill-Bower is hereby appointed as a temporary Building Official / Municipal Law Enforcement Officer for the Corporation of the Municipality of Port Hope and shall have the same powers and authority for enforcement of the Building Code Act, the regulations and By-laws thereunder as the Chief Building Official.
4. That the Chief Building Official and Building Officials may exercise any of the powers to perform any of the duties of an inspector.
5. That this By-law shall come into force and take effect upon the final passing thereof.

READ a FIRST, SECOND and THIRD time and finally passed in Open Council this 6<sup>th</sup> day of December, 2022.
