




Q2 Where is your primary residence located?





Q3 How would you best describe your relationship with the Municipality of Port Hope? (select all that apply)






Q5 Please select which of the following best describes your personal preference for meeting locations:




Q7 Please select which of the following best describes your personal preference with respect to the practice of Question Period at Council and Committee of the Whole:





Q8 What types of public presentations by outside organizations or individuals are most appropriate to present at Council or Committee meetings? (Select all that apply)




Q9 What is an appropriate time limit for public presentations?






Q10 Do you understand the Deputy Mayor role and its purpose?







Q11 Would you like to learn more about the role of the Deputy Mayor?

I'm concerned that if you move to Council and committee meetings during the day, you"ll reduce opportunities for the community to congregate, especially when there are issues of concern to the community. As well, this might prevent an individual who works fulltime, or farms during daylight hours (although farmers do work 24/7 especially if they have livestock) to run for council, I understand there are concerns about the length of some of the meetings. It has always been the case, that when there have been important issues that need to be debated, reviewed, and the public's concerns heard, this may result in some long meetings... but this is no different from other levels of government who sit for long sessions in parliament. Staff can have time off in lieu or come in later next day, but don't cut off the public engagement because a few people are concerned that on occasion there are long meetings. If you feel they can't focus, you can break up the meetings and have short recess to recharge., Evening meetings have served our community well, as this encourages engagement. Pushing all meeting to 9-5 creates less transparency, and will result in the staff being in control of the agenda, and I fear council will hear less from the public.
